

Advance Directive Notification

In the state of Virginia, all patients have the right to participate in their own health care decisions and to make Advance Directives or to execute Powers of Attorney that authorize others to make decisions on their behalf. These decisions are based on the patient's expressed wishes when the patient is unable to make or communicate decisions. VCS HVC respects and upholds those rights.

However, unlike in an acute care hospital setting, VCS HVC does not routinely perform "high-risk" procedures. While no surgery is without risk, most procedures performed in this facility are considered to be of minimal risk. You will discuss the specifics of your procedure with your physician who can answer your questions as to its risks, your expected recovery, and care after your surgery. Therefore, it is our policy, regardless of the contents of any Advance Directive or instructions from a health care surrogate or attorney-in-fact, that if an adverse event occurs during your treatment at this facility, we will initiate resuscitative or other stabilizing measures and transfer you to an acute care hospital for further evaluation. At the acute care hospital, further treatments or withdrawal of treatment measures already begun will be ordered in accordance with your wishes, Advance Directive, or health care Power of Attorney. Your agreement with this facility's policy will not revoke or invalidate any current healthcare directive or health care Power of Attorney.

If you wish to complete an Advance Directive, copies of the office State forms are available at our facility.

If you do not agree with the facility's policy, we will be pleased to assist you in rescheduling your procedure.

Disclosure of Ownership

The partner(s) below make up the ownership of VCS HVC ASC. An interest in the facility enables the physicians to have a voice in the administration and medical policy of the surgery center.
